

If a parent/carer is requesting the appointment please ensure your son agrees with this decision and wishes to attend.















#### St. Malachy's College Uniform Regulations

(Parents are asked to retain this document for reference throughout the year)

Students must always be clean, neat and properly shaven.

Students and parents are reminded that, if a student is in breach of regulations, College Policy is to issue appropriate sanctions.

Items worn or carried in breach of these uniform regulations are liable to be confiscated For a first offence, the item will be returned at the end of the school day. For a second offence, parents will be asked to collect the item.

Full College uniform must be worn not only during the school day, but also when students are coming to and going home from school.

#### The College uniform consists of:

#### SHIRT:

White regulation shirt (no coloured/patterned T-shirts should be worn underneath.) Shirts MUST NOT be worn "out" i.e. over the trousers.

#### TIE:

College Tie only.

#### PULLOVER:

If a pullover is worn, it must be a College pullover. (Sixth Form students may wear a plain black V-neck pullover but the College tie must be seen.)

#### BLAZER:

Black with the College badge. Must be worn to and from school and when moving around the College.

#### TROUSERS:

Black regulation school trousers. (Chinos, denims, etc. are not permitted.)

#### SOCKS:

Plain black socks. (Light coloured or patterned socks are not permitted.)

#### SCARF:

If a scarf is worn, it must be a College scarf.

#### SHOES:

Plain black school shoes. (Boots, trainers, canvas or suede shoes are not permitted.)

#### HAIR:

Style to be acceptable in the judgement of the College authorities; neat; clean. (Styles not

acceptable include: longer than collar length; no shorter than a No2 cut; too long at the front; spiked; dyed etc.) Students with inappropriate haircuts will be referred to the Head of Year who will contact parents, a Saturday Detention will be issued. For a very extreme haircut or a second offence of inappropriate haircut, an internal suspension will be issued. Parents will be informed and work will be provided.

Persistent offences will be regarded as a major breach of College discipline and will incur an official suspension.

#### JEWELLERY:

lewellery must not be worn.

#### SCHOOLBAGS:

Must be waterproof and strong, suitable for the carrying and protection of books. There must be no graffiti of any kind on schoolbags.

#### OUTDOOR WEAR:

The official College Overcoat which is plain, black and longer than blazer length is compulsory. Students may only wear the official College Overcoat. To ensure Road Safety, it is recommended that students wear reflectors such as armbands or attached to schoolbags when travelling to and from the College.

N.B. All items of clothing, sportswear and personal property must be marked clearly with the owner's name and class.

### **Mobile Phones in School**

- Phones must be turned off during the school day. If not already turned off, your son must do so during morning registration.
- Phones must not be used between classes in the corridor, outside or in the toilets. This includes no use of phones during break and lunch time.
- The only time that phones may be used is under the guidance and direction of the teacher during class.
- Contact home should be made through the office or matron.

### **Drugs and Alcohol Policy**

The Drug Education Policy states that:

The College forbids a pupil from:

- Smoking (including chemical/electronic cigarettes) or bringing cigarettes on to site
- Smoking, including the use of electronic cigarettes is forbidden and will be dealt with through the College Positive Behaviour Policy and Stepped Consequences.

Vaping or possession of a vape will incur sanctions.

1st Offence - Saturday DT

Any following - A more serious sanction.

### **Drugs and Alcohol Policy**

Please note that if your son is with a group of boys who are vaping, he may be issued with a sanction even if he is not vaping or in possession of a vape at the time.

Electronic cigarette liquid refill bottles are also forbidden. There is a potential risk that refillable cartridges used in some electronic cigarettes could be filled with substances other than nicotine, serving as a new and potentially dangerous way to deliver drugs. Any instances involving potential use of or possession of drugs will be referred to the PSNI.

#### Our Drug Education Policy states that:

- Possession of and/or taking controlled or illegal substances will be dealt with through the Suspensions and Expulsions Policy
- Possession of with intent to supply or supply of controlled substances will be dealt with through the Suspensions and Expulsions Policy and will lead to Expulsion.

# Attendance and Punctuality for St Malachy's College Students

It is a parent's responsibility to inform the College of the reason for a pupil's absence on the first day of absence. This should be confirmed with a written note/email when the pupil returns to school. If the absence is likely to be prolonged, this information should be provided to enable the school to assist with homework or any other necessary arrangements which may be required.

For return to school following an injury where crutches are required or mobility is hindered, an appointment must be made with the College Matron or the Learning Mentor for the particular Key Stage so that a risk assessment can be conducted and support mechanisms put in place.

Pupils are expected to be in school at St Malachy's College for registration and the beginning of classes. It is the responsibility of parents to ensure their child is punctual. Lateness is recorded at registration and on each child's attendance record.

If a child appears reluctant to attend school parents/carers should discuss the matter promptly with the Form Tutor or Head of Year to ensure that both parents/carers and the child receive maximum support.

### **Behaviour Policy**

The aim of this communication is so that you can see your son's achievements and that you are aware of any issues he may need to address regarding work and behaviour.

The App uses 2 colours Red and Green. We cannot change this. Some information such as a visit to Matron will show in Red. This does not mean your son has been given a demerit and is simply for your information.

The Form Tutor and Head of Year will continue to contact you if demerits are accumulating. However, we hope that direct communication through ParentApp will give you the opportunity to talk to your son and support him with any issues arising.

Please be aware that class teachers will not be available to discuss or justify reasons for giving demerits. Please do not email or ring reception regarding this. We will continue to use our Stepped Consequences through which the Tutor and Head of Year will communicate with you.
